Furthering our charitable purpose as part of Berkshire Health Systems, Fairview Hospital's Community Benefit Mission is to identify, prioritize and address our community's health needs and improve its health status. The overall health status of the region indicates major health disparity among residents, compounded by the complex challenges of a rural environment. As the central provider of primary healthcare, Fairview reviews and develops plans to improve access to health services, strengthen the medical services available, identify and target the needs of vulnerable populations and steward public health status. Fairview Hospital seeks input and meaningful collaboration as it sets goals and implements programs to improve health status and address community needs.

Key Accomplishments of Reporting Year

In FY17, Fairview made significant advances in contributing to a healthier southern Berkshire service area through the continuation of the Canyon Ranch Institute's Life Enhancement Program and collaborating with Berkshire Medical Center's PWTF and the Berkshire Partnership for Health, bringing important health services to hundreds of people in our community identified as at-risk. In addition, Fairview expanded cardiology services, including cardiopulmonary rehabilitation services, as well as nutrition and diabetes education and management programs, which address significant health issues facing our community. Free education programs and increased collaboration with area events provided more engagement with our communities and the people we serve. Noting the priority issue of access to physicians, Fairview Hospital continues to play a role in strengthening access to medical care through physician recruitment in both primary and specialty care services, coordination of care, and improving access in a federally designated Medical Shortage Area and underserved rural community. Fairview Hospital also served as a launching partner of the Summer Backpack Program, tied to at-risk elementary students, whose families face food insecurity during summer months, sponsored driver safety programs for teens and seniors. Fairview is part of a collaboration with local physician practices to help doctors better educate patients about the dangers of drug addiction from pain killers and alternative pain solutions when they prescribe medications. Fairview also provided area first responders supplies, clinical guidance and training to raise the level of pre-hospital emergency care to strengthen the rural network of care.

Plans for Next Reporting Year

Fairview Hospital will continue to focus on overarching issues of access to healthcare, chronic disease management, prevention and education, as well as community building and the continued development of a medical community and a strong rural emergency network. In addition, Fairview will continue to address identified community needs including opioid abuse, driver and pedestrian safety, pertussis and a continued commitment to raise the health literacy of our community.

Fairview will make post-acute cardiac care available to individuals locally to decrease the likelihood of a recurring cardiac episode or help them improve their quality of life with cardiac disease.

In FY17, Fairview's program expanded to offer three levels of cardiac rehabilitation which served over 120 patients.

Fairview will provide an ongoing service to promote functional and emotional health among individuals with Parkinson's Disease.

Fairview offered a weekly support and exercise program that served 17 unique patients, more than doubling the number from FY16.

Fairview has identified the high rate of COPD and oxygen-dependent patients in our community and will offer services to these individuals.

Fairview's Pulmonary Rehabilitation Program offers a supportive, evidence-based program that provides a safe environment to improve exercise tolerance, therapy, monitoring and education to 37 unique patients in both regular and maintenance programs.

Citing the high rate of vehicular death due to cell phone use during driving, Fairview will raise awareness of this dangerous habit in our community. Fairview Hospital sponsors radio ads which encourage drivers to put down their phones and reinforce the awareness of the dangers of driving while texting.

Citing the high number of seniors in our community, Fairview will sponsor programs designed to improve driving skills. Fairview Hospital sponsored three AARP Driver Safety Programs for area seniors.

Fairview Hospital serves a rural community where not all services are easily accessible. Fairview will partner with national and regional organizations to bring important services to our rural neighbors. Fairview Hospital partners with The Alzheimer's Association, the BMC Cancer Center, HospiceCare in the Berkshires, FEMA, MEMA, Elder Services and other organizations to provide access to information and support.

Fairview will implement a telemedicine grant Fairview Hospital oversaw a grant-funded

designed to provide behavioral health services to patients in need. telemedicine initiative which connected behavioral health services to primary care providers.

Fairview will support access to immunizations that will improve the health status of the community. Fairview Hospital offered three free flu vaccination clinics that took place in local schools to be more accessible to families.

Fairview will support access to immunizations to high vulnerable populations that will improve the health status of the community. Fairview Hospital offered free tDap vaccinations at the three local flu clinics to address the spike in pertussis reported the previous year.

Citing food insecurity in the community, Fairview will support local initiatives to provide food for vulnerable families and individuals. Fairview donated over 300 meals to the local homeless shelter. Fairview is also a key partner in the Summer Backpack Program for children and their families during the summer months when school food programs are not available. Fairview donates over \$1000 to food pantries and staff work handing out food at the monthly food distribution of the Western Mass Food Bank.

Fairview Hospital will offer free and low-cost programs to increase health literacy in the southern Berkshire community.

Fairview Hospital offers over twenty community programs that provide community access to important health information that respond to prevalent community need. Programs included Asthma, COPD and Respiratory Distress, Eye Care, Asthma in Children, Dizziness and Vertigo, Ergonomics for the Home Work Station, Living with Cancer, Caregiving- Helping Your Loved Ones and Yourself, Resources to Help Navigate, Mindful Eating Awareness, and other topics to support our community having access to health information.

Citing the danger of visibility on the roads, Fairview will participate with area agencies to increase the visibility of pedestrians.

In conjunction with TRIAD, Fairview Hospital donated 720 high visibility vests to area senior agencies in order to make pedestrians more visible to drivers.

Fairview Hospital convened a task force to build stronger relationships and align efforts of Fairview Hospital and local government leaders to address the opioid epidemic in our community. Meetings take place bi-monthly at Fairview Hospital and the group has discussed prescriber practices and effective patient education.
